If you sell between \$5,000 and \$18,000 per year, a \$50 fee applies to your registration Missouri¹⁷ Fermented foods—Sauerkraut, kimchi and kombucha tea are fermented foods and must be made in an inspected facility Nebraska¹⁸ Fermented food—fermented foods may not be sold at farmers' markets without a permit North Dakota^{19,20}
